As of January 1, 2019, Medicare is placing a preliminary limit on the amount they pay for outpatient physical therapy. The therapy cap amount is \$2040.00. This limit is for both physical therapy and speech therapy services combined.

Muscle & Spine Rehabilitation Center will not compromise your care in any manner; we will assist you in tracking your visits and limits. If you reach your limit, we will work with you on a self-pay basis or to extend your care via the Therapy Cap Exception process, if you qualify.
